Release, Waiver and Assumption of Risk

I, _____, for good and valuable consideration, the receipt whereof being hereby acknowledge, do hereby agree and acknowledge:

1. That I have read and understand fully this RELEASE, WAIVER AND ASSUMPTION OF RISK agreement;
2. That the said RELEASE, WAIVER AND ASSUMPTION OF RISK agreement is on the whole beneficial to me;
3. That I do hereby release the CHATHAM TENNIS CLUB, its members, officers, directors, employees from all liability, and do hereby waive as against the Club, its members, officers, directors, employees all recourses, claims, causes of actions of any kind whatsoever, in respect of damages I might suffer as a consequence of my sustaining personal injury or property loss while participating in the Chatham Tennis Club programs and activities conducted by the Club, notwithstanding that such negligence of the said Club, or any of its members, officers, directors, or employees.
4. That I do hereby agree to indemnify and hold harmless the Chatham Tennis Club ("the Club"), its members, officers, directors, employees, from any and all claims, demands, causes of actions of any kind whatsoever including those involving negligence on the part of the Club or any of its members, officers, directors, employees that may be made or initiated by, or on my behalf, arising out of or connected with my preparation or participation in any of the Chatham Tennis Club programs or activities referred to in the RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement.
5. That I understand clearly that the Club is and shall be deemed to be acting for itself and as agent on behalf of and for the benefit of the members, officers, directors, employees of the Club for the purposes set out in the above-stated clauses of the agreement.
6. This RELEASE, WAIVER AND ASSUMPTION OF RISK, is binding upon myself, my heirs, personal representatives and assigns and enures to the benefit of the Chatham Tennis Club, its successors, and assigns, and its members, officers, directors and employees from time to time.
7. This RELEASE, WAIVER AND ASSUMPTION OF RISK can only be revoked in writing, with notice thereof delivered to the Chatham Tennis Club and hereby a player having signed a valid RELEASE, WAIVER AND ASSUMPTION OF RISK, may play in the Club's activities.
8. I agree to abide by the rules, regulations and constitution of the Chatham Tennis Club and I state that I have read and signed this RELEASE, WAIVER AND ASSUMPTION form voluntarily of my own free will as a reasonable consideration for the privilege of participating in the Chatham Tennis Club, such consideration being a reasonable and sufficient consideration to me and I acknowledge that anyone not signing this RELEASE, WAIVER AND ASSUMPTION OF RISK form is not permitted to participate in the Chatham Tennis Club.
